## **Annual Dues Billing Mailed**

The annual billing for Smithwick Crossing homeowner's dues is included with this newsletter All homeowners are responsible for paying their annual dues of \$305. Please make checks payable to Smithwick

Crossing Homeowners Association. All dues that have not been paid by the pool opening will be assessed late fees of \$25 per quarter.

Homeowner dues cover important amenities for our neighborhood including the pool, landscaping, electricity, phone service and our website. Over the past few years, the Board has worked extremely hard to keep costs to a minimum and manage our annual budget effectively. NOTE: Homeowner accounts that are more than one year past due on HOA assessments, will be turned over to our attorney for collection of all monies and may also be billed for legal fees.

## 2017 POOL KEY



For the safety and security of our residents, the pool is rekeyed each year. Your pool key for the 2017 swim season will be mailed in April once the HOA has received your 2017 HOA dues.

#### **VIOLATION ALERT**

Smithwick Crossing is a Covenant Community. Whether you have read them or not, every homeowner in Smithwick Crossing is bound by restrictive Covenants. At closing, all homeowners sign a document acknowledging receipt and understanding of the Covenants. These Covenants are a legally binding agreement filed at the courthouse. When enforced, Covenants protect property values.

There have been several violations noted recently. Please make sure you are familiar with our Covenants and comply with them. Common violations are listed in the box to your right. Commercial vehicles, house trailers, mobile homes, motor homes, recreational vehicles, campers, trucks with camper tops, boats, boat trailers, or like equipment are allowed on a temporary basis not to exceed 48 consecutive hours. These may be stored on a lot, provided they are kept in an enclosed space and concealed from view by neighboring residences and streets.

The HOA requests that all homeowners be respectful of one another: refrain from hosting loud parties; no trespassing on neighboring property without permission; park in driveways whenever possible; regularly maintain your yard; adhere to rules (above) regarding storage of RVs, boats, etc.

#### THE HOA WILL BE SENDING OUT INDIVIDUAL LETTERS TO THOSE IN VIOLATION!
